














- DA Project on Identifying and Using Inventions in the Public Domain approved during CDIP/27 in November 2021.
- Objectives:
 - Equip TISC staff, researchers, and entrepreneurs with practical tools to help collect
 and analyze data to evaluate a new product development initiative and support
 decision-making in the development of new products and services based on
 inventions in the public domain
 - Develop tools to effectively support the commercialization of new technologies and services building on information and inventions in the public domain, ensuring that those innovations align with market demand and provide tangible benefits and value



- Development Agenda Recommendations:
 - Recommendation 16: Consider the preservation of the public domain within WIPO's normative processes and deepen the analysis of the implications and benefits of a rich and accessible public domain.
 - Recommendation 20: Promote norm-setting activities related to IP that support a robust public domain in WIPO's Member States, including the possibility of preparing guidelines which could assist interested Member States in identifying subject matters that have fallen into the public domain within their respective jurisdictions.








- New modular blended-learning training approach, with mix of digital materials available for self-learning, and resources and datasets for training simulations in instructor-led in-class or online seminars
- Strengthen ownership of the learning process, combining self-learning with instructor-led classes and practical group exercises with clear tasks
- Animations produced by Lambda Films Ltd for WIPO, in collaboration with Foresight Science & Technology and Arendt Speser






- Piloting in selected TISCs in Malaysia and Philippines
- 31 TISC staff participated in a 7-week virtual training, with 2 sessions per week and practical group exercises in mixed teams from Malaysia and Philippines, in line with the ASEAN regional TISC network objective to foster cooperation among its members
- Feedback from participants helped fine-tune the Toolkit materials and training package to make these more effective



100% of respondents to final survey said that the training had been successful in improving their knowledge and skills in this area

71% reported that the knowledge and skills gained would be very useful and the other 29% that it would be somewhat useful.



- Adapting and scaling up the training to other eligible TISC networks, integrating it into WIPO's regular training offerings for TISCs, including translation into other official languages.
- Integration into other related activities and projects, e.g., IP commercialization ('Scale Up Your IP' initiative), technology transfer, IP for business...
- Integration into future TISC staff specialization certification program
